

## Changes to My Care Record in light of COVID-19 Response

We would like to make you aware that the *My Care Record* approach is being used to support additional uses of patient information during the coronavirus (COVID-19) pandemic.

The *My Care Record* website has been updated to reflect this change including a supplementary Privacy Notice addendum specifically for coronavirus (COVID-19).

## In particular please note:

- Practices in additional regions (Bedfordshire, Mid and South Essex, Cambridgeshire and Norfolk) will share information from patient records specifically for the purposes of COVID-19 response. Some regions may start to do this before others.
- In addition to the list of partner organisations involved on the My Care Record website, the approach will cover information sharing for the purposes of COVID-19 response at other services in the East of England. For example, designated centres for the management of critically ill patients including the NHS Nightingale Hospital in London.
- Previous opt-outs (including National Data Opt-Out) are not valid in this situation.

In addition, please note that a change has been made to the way Summary Care Records are made available to support the response to coronavirus (COVID-19). Where a patient has not previously expressed a preference with regard to their Summary Care Record, both the core and additional information will be included in a patient's SCR by default. ## What do practices need to do?

Please ensure that My Care Record information remains prominent on your website. The
most recent text for practice websites can be found <a href="here">here</a>. If it is already well displayed, there
is no need to take further action. If you would like to let your patients know about how My
Care Record is supporting the response to the coronavirus (COVID-19) pandemic, text is
provided below.

We anticipate that the number of queries will be low, however, please contact your Data Protection Officer (DPO) if you have any questions.

- If there is a need to share information for the purposes of COVID-19 treatment or care, you should feel confident to do so. In addition to the normal legal basis provided by the General Data Protection Regulation, the Secretary of State has also issued Control of Patient Information (COPI) notices to give health organisations and local authorities the security and confidence to share the data they need to respond to coronavirus (COVID-19). - As previous opt-outs (including National Data Opt-Out) are not valid in this situation, if a
  patient who has previously objected to share their record is referred for treatment for
  COVID-19, the sharing-out setting may need to be temporarily amended on your clinical
  system.
